

RULES AND REGULATIONS OF THE CONTEST

Section 1

SAFI, Salons Français et Internationaux, Limited Company with a board of directors and a supervisory board, with a capital of 518.080 Euros, whose registered office is located at 8 Rue Chaptal, 75009 Paris, registered with the Registre du Commerce et des Sociétés de Paris [Paris Trade Register] under the number 388 424 129, is organising a prize draw from 06/06/2018 to 02/07/2018, the terms and conditions of which are detailed in the present Rules and Regulations (hereafter, the "Prize Draw").

Section 4

SAFI reserves the right in the event of force majeure, or on any grounds beyond its control, to replace the Prize by a different equivalent Prize of equivalent value.

The Winner shall be identified by the MOM account creation form (s)he filled out

(s)he will be contacted via email. The Winner will be identified via the account creation form he/she filled out. This individual will be contacted by e-mail. The winner must confirm acceptance of the item within two weeks from receipt of the e-mail informing them of the prize they have won. Any prize not claimed within this period of time will be considered as remaining the property of SAFI.

The prize will be mailed, at the expense of SAFI.

SAFI reserves the right to verify the identity of the Winner.

In addition, under no circumstances shall SAFI be held liable in the event of loss of emails.

Under no circumstances shall SAFI be held liable for the loss or deterioration of user data or of any direct or indirect harm of any kind (tangible, intangible, financial, or other) arising on the occasion of entry in the contest.
